

ScottishPower EV Charger 2,500 Free Miles Account Credit Offer Terms & Conditions

- 1. The promoter is ScottishPower Energy Retail Limited (company number SC190287), which has its registered office at 320 St. Vincent Street, Glasgow, G2 5AD (the "Promoter").
- 2. The promotion is the award of an account credit (exclusive of VAT) in accordance with these terms and conditions (the "**Promotion**") to Qualifying Applicants (as defined below).
- 3. The Promotion will run for the period beginning on 27th November 2023 and shall continue until such time as the Promoter decides to end the Promotion (the "**Promotion Period**").
- 4. The Promotion is open to applicants who meet the following eligibility criteria ("Qualifying Applicants"). Applicants must:
 - 4.1. be legally resident in the UK (excluding Northern Ireland);
 - 4.2. be aged 18 years or over:
 - 4.3. purchase a ScottishPower Smart Electric Vehicle Home Charger ("**EV Charger**") during the Promotion Period either via the Promoter's inbound telesales line (0800 027 0004), or via the ScottishPower EV charger website online sales journey (https://www.scottishpower.co.uk/electric-vehicles/chargers).
 - 4.4. be a ScottishPower customer for electricity supply to their household, either on or before;
 - 4.4.1. the start of the Promotion Period; OR
 - 4.4.2. the date that an EV Charger is installed; OR
 - 4.4.3. within 30 days of an EV Charger being installed.
 - 4.5. have their EV Charger installation completed at the same address applicable to their relevant energy account within the Promotion Period. A grace period of 90 days will apply from the end of the Promotion Period for charger installations to be completed. If the charger installation falls outside this grace period, the Promoter shall exercise its discretion in whether to honour the Account Credit.
- 5. The Promoter reserves the right to verify the eligibility of all Qualifying Applicants and has the right to reject any applications that appear to be duplicates, materially incorrect or fraudulent.
- 6. Any applications found to be transacting fraudulently with the Promoter will not be eligible for the offer and may also have their details passed to police authorities for further investigation.
- 7. Subject to clause 8, the Promotion may be used in conjunction with another ScottishPower EV Charger promotional offer, affiliate EV Charger promotional offer or EV Charger offer.
- 8. The Promoter reserves the right to prohibit the Promotion from being used in conjunction with any other ScottishPower EV Charger promotional offer, affiliate EV Charger promotional offer or staff EV Charger offer during the Promotion Period at any time.
- 9. The Promoter will award Qualifying Applicants with an account credit as follows: Where electricity is supplied to the Qualifying Applicant's installation address then the sum of £60.00 (sixty) pounds sterling (the "Account Credit") shall be paid to the Qualifying Applicant's electricity account and will appear on their statement as; EV Promotion £57.14 VAT (5 %) £2.86.
- 10. All Qualifying Applicants from the Promotion shall be paid the Account Credit 30 days after the EV Charger is installed, or, within 30 days of joining ScottishPower as a customer for electricity supply, whichever is the latter. Checks will be made to ensure the Qualifying Applicants remain in contract with The Promoter at the point of the Account Credit being paid. The Account Credit will appear on the Qualifying Applicant's next bill, which shall show the applicable credit (including a breakdown of VAT).
- 11. The Promoter accepts no responsibility for any inaccurate information provided by the Qualifying Applicant which results in the Account Credit not being applied in accordance with clause 9.



12. The Account Credit value is an estimated fixed amount calculated to cover the average cost of charging an Electric Vehicle ("EV") using the Promoters EV Saver off-peak tariff to complete a total of 2,500 miles. Please note this is a fixed sum and is not subject to change based on any of the Qualifying Applicant's specific circumstances. This has been calculated using the following actual known information and assumptions:

7.800p per kWh = the off-peak EV charging rate of the Promoters EV Saver Tariff Assumed average kWh usage per mile of an EV = 3kWh Free miles offer = 2500 miles 2500 miles /3kWh = 833.33kWh 833.33 x 7.200p = £59.99 rounded to £60.00.

- 13. Only one Account Credit will be provided per household.
- 14. Without prejudice to clause 16 the Account Credit calculation referred to in clause 12 is not open for negotiation or reinterpretation.
- 15. The Promoter, its agents or distributors will not in any circumstances be responsible or liable to compensate any applicant or Qualifying Applicant or accept any responsibility or liability for any damage, loss, liabilities, personal injury or disappointment incurred or suffered by any applicant or Qualifying Applicant in connection with the Promotion except where it is caused by the negligence of the Promoter, its agents, or distributors or that of their employees.
- 16. This Promotion may be withdrawn or suspended at any time for new applications by the Promoter. The Promoter also reserves the right to amend these terms and conditions for new applications at any time without prior notice.

- 18. By entering this Promotion, the applicant accepts these terms and conditions. The Promoter reserves the right to refuse entry or refuse to award the Account Credit to anyone in breach of these terms and conditions.
- 19. If the Qualifying Applicant's serviced property is in Scotland, these terms shall be governed by Scots law and shall be subject to the exclusive jurisdiction of the courts of Scotland. If the Qualifying Applicant's serviced property is in England or Wales, these terms shall be governed by the laws of England and Wales and shall be subject to the exclusive jurisdiction of the courts of England and Wales.
